Care Quality Commission (CQC) inspection 2018

We welcomed CQC inspectors back to our services in March – April. This was a new style well-led review which took a comprehensive look at our leadership and a number of our services. 11 of our 14 core services are rated 'Good', with all services rated 'Good' or 'Outstanding' for being caring. Overall, we are rated 'Good' for being well-led, caring and effective, and 'Requires Improvement' for being safe and responsive. This means that we have been rated 'Requires Improvement' as a Trust. 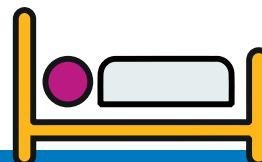
With **all of us** in mind.

Our **COMMUNITY LEARNING DISABILITY SERVICES** have improved and are now **RATED GOOD**



Our acute mental health / psychiatric intensive care wards remain **REQUIRES IMPROVEMENT**



Two core services have been re-rated as **REQUIRES IMPROVEMENT**:

- Community mental health services for adults
- CAMHS



Overall, we are rated Good for being well-led, caring and effective. We are rated Requires Improvement for being safe and responsive. This means that we have been rated Requires Improvement as a Trust.

We put safety first, always, and so our first priority is to address the safety issues highlighted. We're responding in line with our values, being open, honest and transparent and aiming to improve and be outstanding.

More than 85% of our ratings (60 out of 70 individual domains) are rated **GOOD or **OUTSTANDING**.**

We're grateful for the continuing effort and hard work of all our staff right across the organisation.
