Site Visits and learning from others

The information below summarises learning from other trusts as part of the transformation programme. The programme team visited and met with a range of other providers that had established a specialist dementia unit model and explored a range of features in the models including layout and staffing.

A summary of the wards is below. More detail can be made available on request.

TEWV Dementia Unit - Middlesbrough August 2016

TEWV have a 16-bed ward, at Roseberry Park in Middlesbrough, specifically designed for patients with dementia. It acts as a dementia unit for people in Middlesbrough and also surrounding localities including Stockton on Tees, Hartlepool and Cleveland and Redcar. It is adjoined to a 16-bed functional unit with a flex door and 4 flex beds in between the units to increase / decrease capacity as needed.

The unit has a dedicated psychology lead and focusses on a person-centred pathway through their in-patient journey, and the ward adopts a person-centred care approach which firmly places the person, not the dementia, at the centre of care and involves making and taking time to understand the needs and feelings/emotions of people with dementia.

Sheffield Dementia Unit Visit May 2017

Sheffield previously had 3 dementia units and they created a Dementia Rapid response team which enabled a reduction over time to a single 16 bed dementia unit (though the facility still has 20 beds).

The sites cater for people with high needs behaviours – up to a PICU level of care and early onset dementia is in scope.

The Trust have built some flats on the site, created an intensive area and have a seclusion room. Not all bedrooms were en-suite at the time of the visit.

Lancashire Care Trust June 2018

Lancashire Care Trust has a Dementia ward operates out of The Harbour, which has 10 wards in total (4 older adult wards) also provides an older people's functional ward and working aged adult wards.

The site 30 dementia beds in total for the Trust. 1 Male and 1 Female with 15 beds in each. Swing beds are in middle create 2 more beds if needed for each gender (so mix could be 17/13). All rooms are en-suite.

Bradford District Care Trust (BDCT) December 2021

Bradford has Modern and spacious specialist dementia unit. It is the ground floor of a 2-story building that was fully refurbished about 8 years prior.

It has wide corridors and figure of 8 design. Bedrooms are all e/s with toilet and sink.

The ward has 22 beds in total but in recent years the Trust has operated at considerably lower occupancy levels.
